The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be The Cottages at Old Corkscrew Golf Club, LLC (the "Company").

ARTICLE II -- ADDRESS

The mailing address of the Company shall be P. O. Box 613, Bonita Springs, Florida 34133. The street address of the initial principal office of the Company shall be 26811 South Bay Drive, Suite 350, Bonita Springs, Florida 34134.

ARTICLE III -- DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. ARTICLE IV -- REGISTERED OFFICE AND AGENT




