Principal Office

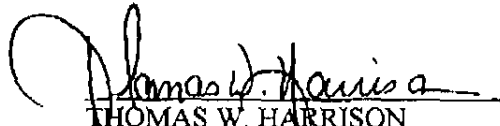
The mailing address and street address of the principal office of the Company shall be 4225 26th Street West, Bradenton, Florida 34205 and the mailing address shall be the same.

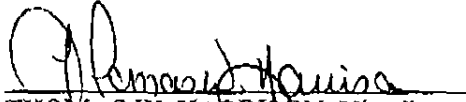
