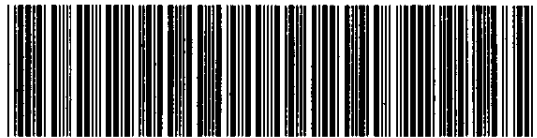

The Company shall commence its existence on February 1, 2010. The Company's existence shall be perpetual unless the company is dissolved earlier as provided herein or as provided by law.

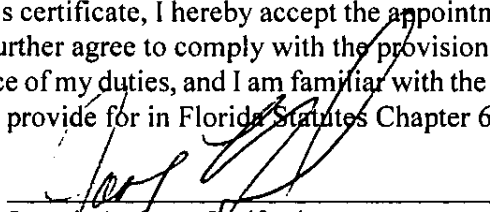

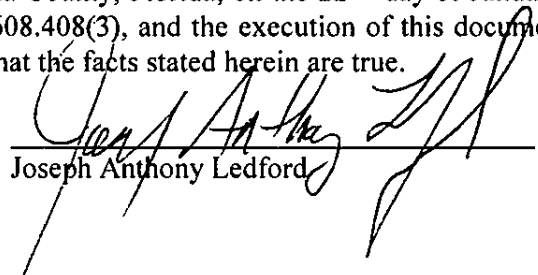
