ARTICLES OF ORGANIZATION OF SKYLINE ASSET SERVICES, LLC

ARTICLE I

<u>Name</u>

The name of the limited liability company is Skyline Asset Services "Company").

ARTICLE II Principal Office

The mailing address and the street address of the principal office of the Company is 2750 N.E. 185th Street, Suite 306, City of Aventura, Florida 33180.
