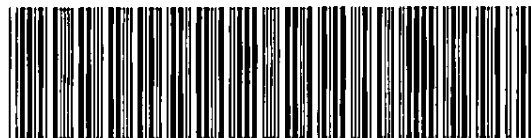

**ARTICLE ONE  
ENTITY NAME**

PRINCIPAL OFFICE AND MAILING ADDRESS**

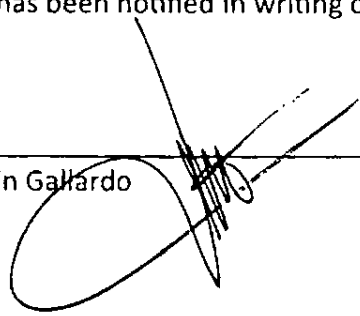

**ARTICLE FOUR

6. To generate revenue through the sale, licensing, and distribution of media and publishing products and services, with all net proceeds supporting the religious and charitable mission of the Church.
7. To engage in any and all activities reasonably related or incidental to the foregoing purposes.
8. To collect and disburse any and all necessary funds for the maintenance of said Company and the accomplishment of its purposes within the State of Florida and elsewhere.

AMENDMENT**

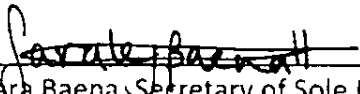
These Articles of Organization may only be amended by the Company's sole member.
