**ARTICLES OF ORGANIZATION
OF
PLANT CITY REAL ESTATE INVESTMENT, LLC**

1. NAME. The name of this limited liability company is Plant City Real Estate Investment, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.


2. PLACE OF BUSINESS. The mailing address and street address of the Company's principal office is 6300 N. Sagewood Drive, Suite H-117, Park City, UT 84098.

4. MANAGEMENT OF THE COMPANY. The Company shall be managed by a manager or managers in accordance with the Operating Agreement adopted by all of the members and is, therefore, a **manager-managed** company. The initial manager of the Company is Ronald E. Scaglione.


