ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION OF CMN INVESTMENTS, LLC

Pursuant to the Florida Limited Liability Company Act, CMN INVESTMENTS, LLC, a Florida limited liability company (the "<u>Company</u>"), hereby adopts the following Articles of Amendment to its Articles of Organization:

FIRST: The name of the Company is: CMN INVESTMENTS, LLC

SECOND: The Articles of Organization of the Company were filed on February 1, 2010 and assigned document number L10000011979.

THIRD: Article 1 of the Articles of Organization of the Company is hereby amended and restated in its entirety as follows:
