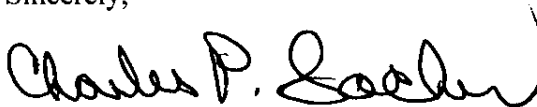

**ARTICLES OF ORGANIZATION OF
PLCHOT HOUSE, LLC**

The undersigned, desiring to form a Limited Liability Company under and pursuant to §608.405, Florida Statutes, does hereby certify as follows:

FIRST: The name of said limited liability company shall be PLCHOT HOUSE, LLC.

SECOND: PLCHOT HOUSE, LLC shall exist in perpetuity.

THIRD: Copies of the Operating Agreement of PLCHOT HOUSE, LLC may be obtained from the Manager at 10601 Snapper Creek Road, Coral Gables, Florida 33156-3545 which is the place in the State of Florida where the principal office of the limited liability company is located. The mailing address of PLCHOT HOUSE, LLC shall be 10601 Snapper Creek Road, Coral Gables, Florida 33156-3545.

FOURTH: The purposes for which PLCHOT HOUSE, LLC is formed are:

- A. 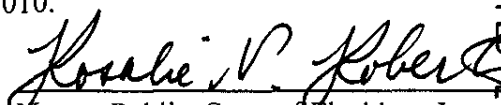
