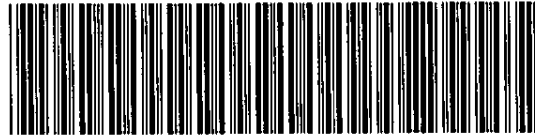


Article I is hereby amended to read:


