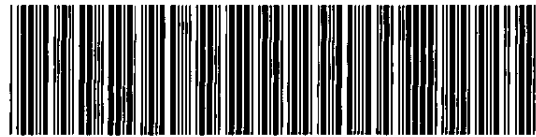



The Manager shall have the right to admit new members. Contributions required of new members shall be determined as of the time of admission to the limited liability company.


A member's interest in the limited liability company may not be sold or otherwise transferred except with the written consent of the managing member.

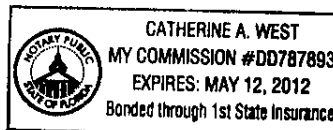
