# ARTICLES OF ORGANIZATION OF

The undersigned, for the purpose of forming a limited liability company ander the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE 6 - REGISTERED OFFICE AND REGISTERED AGENT



#### **ARTICLE 9 - MANAGEMENT**


