NAME

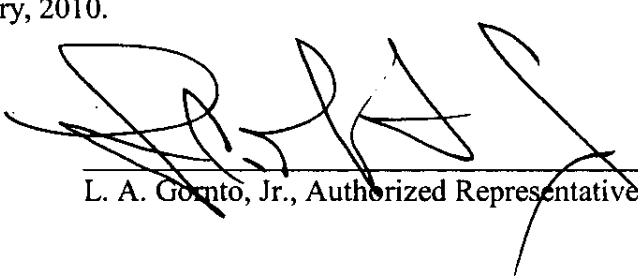

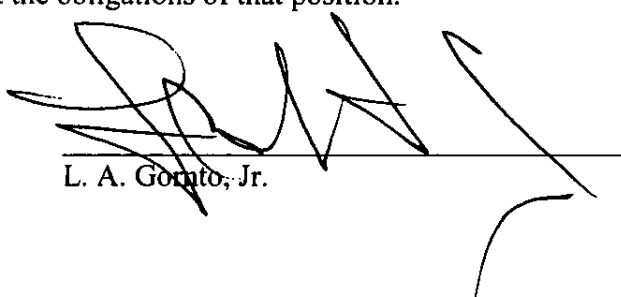
