#### ARTICLES OF ORGANIZATION OF

#### Florida Progress Avenue LLC EIN# 27-1458215

The undersigned, pursuant to the Florida Limited Liability Company Act (the "Act"), adopts the following Articles of Organization for the purpose of organizing a Florida Limited Liability Company (the "Company").

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Members agree as follows:

- 1. Name. The name of the Company is Florida Progress Avenue LLC (the "Company").
- II. <u>Principal Office</u>. The location of the Company's initial Principal Office shall be 6355 Sunset Corporate Drive, Las Vegas, NV 89129. The Company may have such other offices, either within or without the State of Florida as the Managers may designate or as the business of the Company may from time to time require.
- III. Registered Office, Registered Agent. The location of the registered office of the Company shall be: 2209 Collier Parkway, Land O Lakes, FL 34639

The Company's registered agent at such address shall be Linda Smith. The Company may change its registered agent at any time in accordance with the Act. - VI. <u>Purpose</u>. This waiver includes, but is not limited to, any liability of a Member to the Company imposed by Florida Limited Liability Company Act, as amended from time to time.
- 9. Indemnification of Managers, Members, and Employees. The Company shall have the power to indemnify and hold harmless each of its Members, Managers and Employees to the full extent permitted by the Act.
- 10. Member and Manager Contracts. A contract or other transaction with the Company may be permitted regardless of the fact that a Member or Manager of the Company is financially interested in, or may be interested in, such transaction if consistent with the Operating Agreement for the Company.
