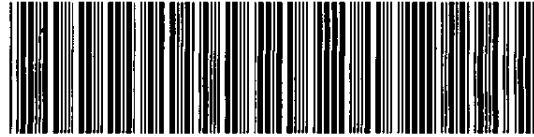



**ARTICLES OF ORGANIZATION OF
MKS OF SWFL, L.L.C.**

**ARTICLE I
NAME**

The name of this Limited Liability Company shall be: MKS OF SWFL, L.L.C.

**ARTICLE II
PURPOSE**


