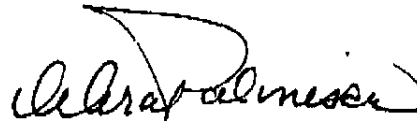

ARTICLE III - Management

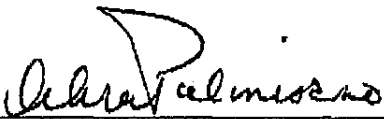
