Effective immediately, Dorothy L. Griggs resigns from her positions as Managing Member and Registered Agent with Advanced Engineering and Surveying, LLC.


Effective immediately, Stanley B. Griggs resigns his position as Managing Member with Advanced Engineering and Surveying, LLC.
