**ARTICLES OF ORGANIZATION OF
AZTEC LAKES BASS FISHING MEXICO, LLC.**

Article I

The name of the limited liability company ("Company") is AZTEC LAKES BASS FISHING MEXICO, LLC.

Article II


Article VII
