**ARTICLES OF ORGANIZATION OF

MEMBERSHIP





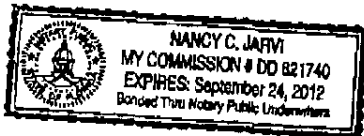
