**AMENDED AND RESTATED  
ARTICLES OF ORGANIZATION OF  
IATROS, LLC**

These Amended and Restated Articles of Organization are submitted in accordance with the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, as the same may be amended from time to time (the "Act").

**ARTICLE I - NAME**

The name of the Limited Liability Company is IATROS, LLC.
