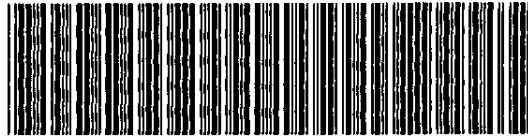


The Articles of Organization for this Limited Liability Company were filed on April 1, 2010 and assigned Florida document number L10000017083.
