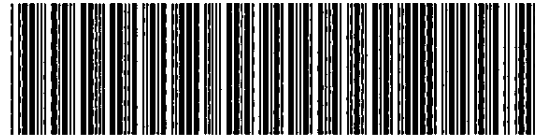


BE IT HEREBY RESOLVED, that the Company is hereby dissolved and shall discontinue any and all operation, on or before February 16, 2012, without formal meeting.


