
**ARTICLE VII**

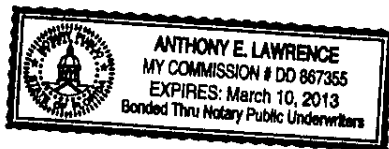


