The name of the Limited Liability Company is SAUNDERS RALSTON DANTZLER REALTY, LLC."

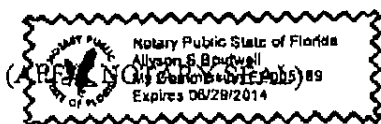
