CONTINUATION OF BUSINESS OPERATIONS




ARTICLE IX

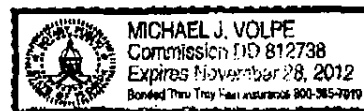
