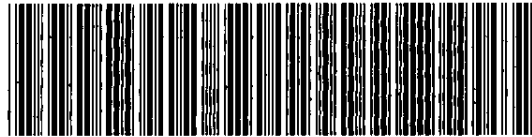

**ARTICLES OF ORGANIZATION
OF
MRE HOLDING COMPANY, LLC**

1. Name. The name of this limited liability company is MRE HOLDING COMPANY, LLC, a Florida limited liability company (the "Company").
2. Duration. The Company shall exist for a term commencing on the filing of the Articles of Organization with the State of Florida and continues until January 1, 2090.
3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida, including real estate investment activities and such other lawful activities as are reasonably necessary, convenient or incidental to this purpose.

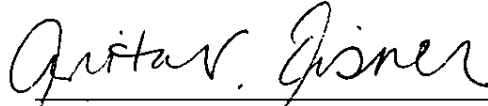
8. Voting. The Company is authorized to issue membership interests with voting rights and membership interests without voting rights.

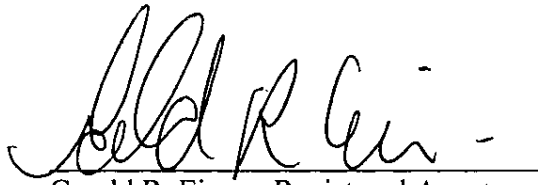
