The name of the limited liability company is CSC Florida Marine LLC.

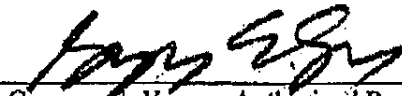
ARTICLE II. ADDRESS
