- (1) A limited liability company organized under this chapter shall be dissolved, and the limited liability
- company's affairs shall be concluded, upon the first to occur of any of the following events:
- (a) At the time specified in the articles of organization or operating agreement, but if no such time is set forth
- in the articles of organization or operating agreement, then the limited liability company shall have a

perpetual existence;

- (b) Upon the occurrence of events specified in the articles of organization or operating agreement;
- (c) Unless otherwise provided in the articles of organization or operating agreement, upon the written consent
- of all of the members of the limited liability company;
- (d) At any time there are no members; however, unless otherwise provided in the articles or organization or
- operating agreement, the limited liability company is not dissolved and is not required to be wound up if,
- within 90 days, or such other period as provided in the articles of organization or operating agreement, after
- the occurrence of the event that terminated the continued membership of the last remaining member, the

- (3) A description of the occurrence that resulted in the limited liability company's dissolution pursuant to s
