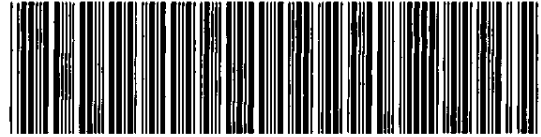

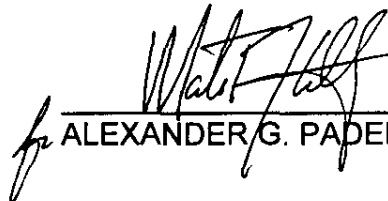

ARTICLES OF ORGANIZATION

OF

BARON GUARANTY, LLC

ARTICLE I - NAME

The name of the Florida limited liability company shall be BARON GUARANTY, LLC.

ARTICLE II - DURATION

The assignee shall merely be entitled to receive the share of profits and other distributions and the allocation of income, gain, loss deduction, credit or similar item to which the assignor was entitled, to the extent assigned.

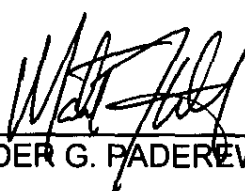
