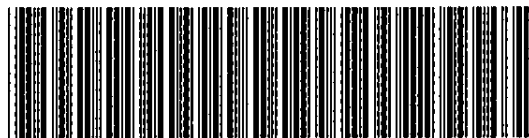

- 8) **Management:** The Company shall be managed by its members, and its name and address is:

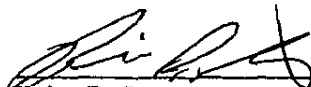

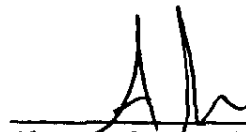
