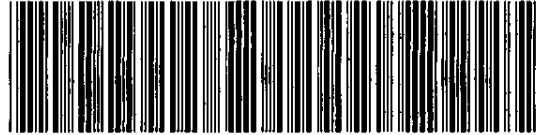

(3). The name of the Florida Limited Liability Company as set forth in the attached Articles of Organization is **Zapata's Restaurant, LLC.**







The following Plan of Conversion is submitted in compliance with Florida Statutes Section 608.439:

**ARTICLE I
CONVERTING CORPORATION**

The name of the Converting Corporation is **Zapata's Restaurant, Inc.** It was first organized on April 14, 2006, as a corporation under the laws of the State of Florida.

**ARTICLE II
CONVERTED ORGANIZATION**

The name of the Converted Organization is **Zapata's Restaurant, LLC.** It is organized as a limited liability company under the laws of the State of Florida.

**ARTICLE III
TERMS AND CONDITIONS OF THE CONVERSION**

The terms and conditions of the conversion are as follows:

(A). Each share of stock in the Converting Corporation shall be converted into one (1) limited liability company unit in the Converted Organization. Collectively, all of the limited liability company units in the Converted Organization shall represent one hundred percent (100%) of all authorized shares of stock.

(B). The Certificate of Conversion for "Other Business Organization" into Florida Limited Liability Company has been signed by each Manager of Zapata's Restaurant, LLC and shall be duly filed with the State of Florida upon approval of this Plan of Conversion.

(C). Each Director hereby recommends that this Plan of Conversion be authorized by the Shareholders.



MANAGEMENT


