ARTICLES OF ORGANIZATION

OF

ALJAMAX, LLC

SECRETARY OF STATE
TALLAHASSEE, FLORIDA

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be Aljamax, LLC.

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the company is 904 White Eagle Circle, St. Augustine, FL 32086.

ARTICLE III -- DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these articles of organization or in the Operating Agreement.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the company in the state of Florida are Glenn D. Brady, 904 White Eagle Circle, St. Augustine, FL 32086

ARTICLE V -- CAPITAL CONTRIBUTIONS

Contributions to the capital of the company shall be made by the member in the manner prescribed by the written Operating Agreement made and entered into by the members and which may be amended from time to time in accordance with its terms.

ARTICLE VI -- ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the company only on the unanimous consent of all the members, or as provided in the Operating Agreement.

ARTICLE VII -- ADMISSION OF NEW MEMBERS

Except as set forth in the Operating Agreement, no additional members shall be admitted to the company.

ARTICLE VIII -- DISSOLUTION OF COMPANY

The dissolution of the company shall be as provided for in the Operating Agreement. In the event there is no Operating Agreement, the company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company.

ARTICLE IX -- MANAGEMENT

The company shall be managed by the manager in accordance with Operating Agreement adopted by the members for the management of the business and affairs of the company. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the company not inconsistent with the law or these articles of organization. 


