The undersigned, for the purpose of amending the Articles of Organization of Media Vista Group, LLC, a Florida limited liability company, hereby makes, acknowledges, and files the following amendment to its Articles of Organization, pursuant to Section 608.411, Florida Statutes.

FIRST: The Articles of Organization of Media Vista Group, LLC were filed with the Florida Department of State on February 24, 2010, and were assigned Document Number L10000020935.

SECOND: The following amendments to the Articles of Organization were adopted by Media Vista Group, LLC.:

1. Article 4 is hereby deleted in its entirety and replaced as follows:

ARTICLE 4 - DURATION

The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization or in the Company's Operating Agreement.

2. Article 8 is hereby deleted in its entirety and replaced as follows:

ARTICLE 8 - [RESERVED]

THIRD: The number of votes cast for the foregoing amendment by the members and manager of the Company was sufficient for approval.

Except as herein amended, the Articles of Organization shall remain in full force and effect as originally executed and filed with the Florida Department of State on February 24, 2010.
