2. (a) Mailing Address. The Company's mailing address shall be 4319 Salisbury Road, Jacksonville Beach, Florida 32216.


(b) Street Address of Principal Office. The street address of the principal office of the Company is 4319 Salisbury Road, Jacksonville, Florida 32216.
