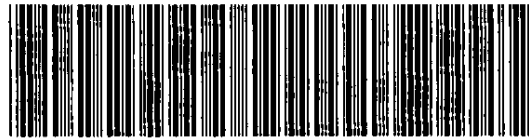


**ARTICLES OF AMENDMENT**
