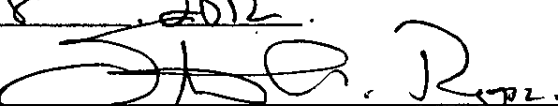

The undersigned hereby adopts these Articles of Organization in order to form a limited liability company under Chapters 608 and 621 of the Florida Statutes.

ARTICLE I—NAME

The name of this limited liability company shall be Rossi's Enterprises, LLC (the "Company")

ARTICLE II—DURATION

The Company shall commence upon the execution of these Articles and shall exist perpetually.

ARTICLE III—PURPOSE

The purpose of the Company is to engage in all and any business that is lawful.

ARTICLE IV—ADDRESS

The initial street and mailing address of the principal place of business of the Company is 693 Ixora Drive, Melbourne, FL 32935.

ARTICLE V—REGISTERED AGENT

The initial address in Florida of the initial registered office of the Company is 693 Ixora Drive, Melbourne FL 32935. And the name of the initial Registered is Terri L. Rossi.

ARTICLE VI—ADMISSION OF ADDITIONAL MEMBERS
