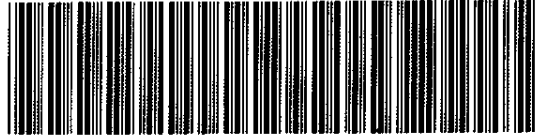

**THE ARTICLES OF ORGANIZATION  
FOR

**Article I. Name.**

The name of the company is: LAW OFFICE OF TERRY LENICK, P.L.

**Article II. Principal Office and Address.**

**Article III. Purpose.**

The purpose for which the Company is organized is to render professional legal services and all other lawful business permitted under the laws of the United States and the State of Florida.

**Article IV. Transferability of Membership Interests.**

No member shall have the right to assign their membership interests in the Company without the written agreement of all of the membership interests, unless otherwise provided in the Company's Operating Agreement. The voting members shall have complete discretion on when and if to approve any distribution of profits.




