### **ARTICLES OF ORGANIZATION**



### **HELP MY HEEL LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

### **ARTICLE 1 - NAME**

The name of the limited liability company shall be **HELP MY HEEL L** ("Company").

### **ARTICLE 2 - ADDRESS**
