## PLAN OF MERGER

FIRST: GRE Orlando, Inc., a Florida corporation, is the merging party (the "Merging Corp.").

SECOND: GRE Properties Orlando LLC, a Florida limited liability company, is the surviving party (the "Surviving LLC").

THIRD: The terms and conditions of the merger are as follows:
