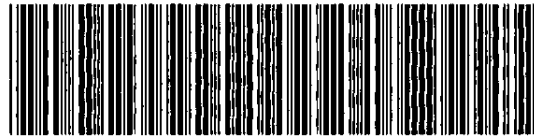

1. NAME. The name of this limited liability company is BDG 6105, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.


2. PLACE OF BUSINESS. The mailing address and street address of the Company's principal office is 6654 – 78th Avenue North, Pinellas Park, Florida 33781.


