### ARTICLES OF ORGANIZATION

<u>OF</u>

### RENMUS PROPERTIES, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

### ARTICLE I - NAME

The name of the limited liability company shall be RENMUS PROPERTIES, LLC. The street address of the principal office of the limited liability company in Florida shall be 8803 Pritcher Road, Lithia, Florida 33547, and the mailing address shall be PO Box 4044, Plant City, Florida 33563.

# ARTICLE II - DURATION

### ARTICLE III - PURPOSES AND POWERS

The specific purpose for which this limited liability company is organized is to buy, sell, lease and manage real estate. # ARTICLE VI - ADDITIONAL CAPITAL CONTRIBUTIONS


