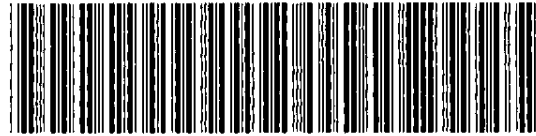

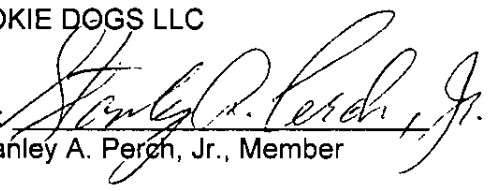
**SECOND:** The date of the adoption of these Articles of Dissolution is 03 January 2011.
