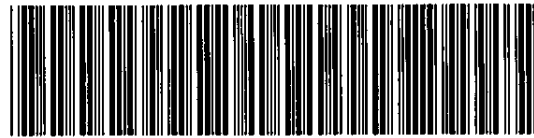

## ARTICLE III: Purpose of the PoliConnect, LLC:


