The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be **IL SANDALO WHOLESALE, LLC** ("Company").

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Company shall be 361 South County Road, Suite I, Palm Beach, FL 33480.

ARTICLE III - DURATION


ARTICLE IV - REGISTERED OFFICE AND AGENT

ARTICLE V - MANAGEMENT


