ARTICLES OF ORGANIZATION
OF
SWIM WITH BECKY AND FRIENDS, LLC

For the purpose of organizing a Limited Liability Company, pursuant to Chapter 608, Florida Statutes, the undersigned submits the following Articles of Organization:

1. The name of the Limited Liability Company shall be SWIM WITH BECKY AND FRIENDS, LLC.

2. The duration of the Limited Liability Company shall be perpetual.

3. The mailing address and street address of the principal office of the Limited Liability Company is 1449 Timbercrest Drive, Deltona, Florida 32738.

4. The initial Registered Agent of the Limited Liability Company is Patricia M. Magill, Esquire, whose address is 1234 East Concord Street, Orlando, Florida 32801.
