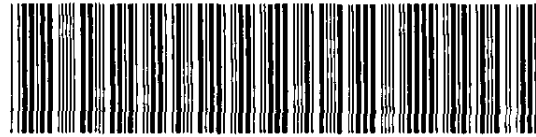

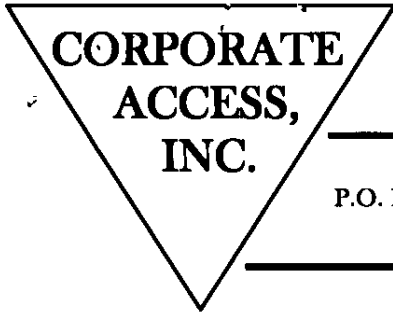

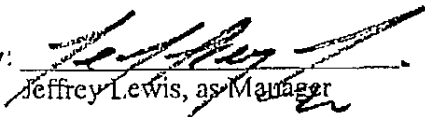
3. The foregoing amendments were adopted by all Members and Managers of the Company as of the 18th day of August, 2010.

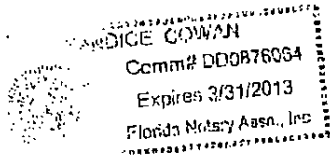
