ARTICLE 1 - NAME

The name of the limited liability company shall be **THE ORIGINAL OASIS LLC** ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 205 Mountain Drive, Destin, Florida 32541 and the mailing address shall be the same.

ARTICLE 3 - EFFECTIVE DATE

ARTICLE 4 - DURATION




