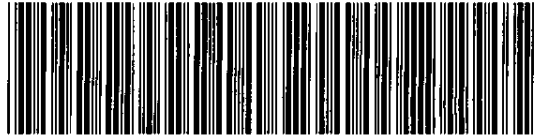

**ARTICLE I


