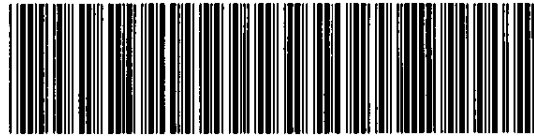

ARTICLES OF ORGANIZATION

OF

ICONIC INNOVATIONS MEDIA GROUP, LLC

Pursuant to the Florida Limited Liability Act, Chapter 608, Florida Statutes, as amended from time to time (the "Act"), the following are adopted as the Articles of Organization of the limited liability company organized hereby:

ARTICLE I NAME

The name of the limited liability company (the "Company") shall be ICONIC INNOVATIONS MEDIA GROUP, LLC.

ARTICLE II DURATION

Unless earlier terminated pursuant to the Act or the Operating Agreement (as defined in Subsection 608.402(24) of the Act) of the Company, the period of its duration shall be perpetual.

ARTICLE III ADDRESS

The mailing address and the street address of the principal office of the Company shall be 60 Ocean Boulevard, #13, Atlantic Beach, Florida 32233.

ARTICLE IV REGISTERED AGENT

The Company hereby designates Kevin K. Porter as its initial Registered Agent, and the initial registered office of the Company shall be 60 Ocean Boulevard, #13, Atlantic Beach, Florida 32233.

ARTICLE V ADDITIONAL MEMBERS

Additional members (as the term "member" is defined in Subsection 608.402(21) of the Act) may be admitted at such times and on such terms and conditions as provided in the Operating Agreement of the Company.

**ARTICLE VI
CONTINUATION OF BUSINESS**

The remaining members of the Company may continue its business upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of the member or members in the Company as provided in the Act or the Operating Agreement of the Company.

**ARTICLE VII
MANAGEMENT OF THE COMPANY**

The Company will be a member managed company managed by one of its members in accordance with and subject to the requirements of the Act and the Operating Agreement of the Company.

IN WITNESS WHEREOF, the undersigned, being the Managing Member of the Company, has executed the Articles of Organization on behalf of the Company in accordance with Subsection 608.407(4) of the Act.
