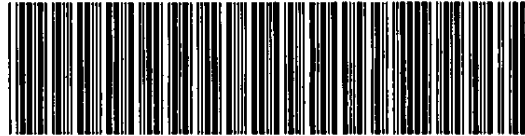

The business has been dormant for the past year and operation has ceased, so decided to dissolve LLC to avoid


