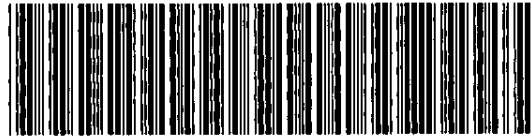

I hereby form a Limited Liability Company under the provisions set forth in Chapter 608.401 of the Florida Limited Liability Act and to that end set forth the following:

**ARTICLE I**

The name of the Limited Liability Company is SolarTek Energy Solutions LLC (the "Limited Liability Company").

**ARTICLE II**

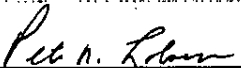
**ARTICLE VI**
